THERMOTEK™ GROUP warrants to the Building Owner ("Owner") that during the previously mentioned period, THERMOTEK™ GROUP will, subject to the Terms, Conditions and Limitations set forth below, will replace whichever THERMOTEK™ product necessary to repair any leak and/or damage on the THERMOTEK™ Roofing System as a result of weathering due to ordinary exposure to the elements or any manufacturing defect in the THERMOTEK™ product. Customer should prove the product failure has occurred somehow during the warranty period, upon presentation of this warranty certificate. THERMOTEK™'s replacement obligation over the life of this warranty is limited to the Owner's original cost of the THERMOTEK™ Roofing System. This limited warranty does not cover: application or investigation costs, additional application materials, used in the application, related costs needed for the replacement product or transportation costs. Failure by Owner to pay for these costs shall render this "THERMOTEK™ Product Limited Warranty" null and void.

TERMS, CONDITIONS AND LIMITATIONS

In the event there is a failure during the warranty period associated with a manufacturing defect of the THERMOTEK™ product(s) installed, THERMOTEK™ GROUP shall, at its own discretion, provide the appropriate THERMOTEK™ products(s) to return the warranted THERMOTEK™ Roofing Product(s) to the proper condition. This Limited Warranty is also subject to the following additional terms and conditions:

A. SUBMISSION: Completed warranty form must be returned to THERMOTEK™ GROUP within 30 days after completion of job. Completed form must be mailed via certified mail to: Pinturas Thermicas Del Norte, S.A. de C.V., P.O. Box 1209 San Darlo Ave. PMB 7 - 1 Laredo, TX. 78040-4515.

B. PRODUCTS & INSTALLATION: this warranty is only applicable when THERMOTEK™ products are properly installed according to published THERMOTEK™ Specifications (Technical Data Sheets and Application Guides). C. EFFECTIVE DATE: This warranty shall not become effective until all bills for installation, materials and services sold in conjunction within this project are paid for in full. The Owner must prove to THERMOTEK™ GROUP the liquidity of all the bills, and receive a notification via e-mail of the reception of this completed form. D. EXCLUSIONS FROM COVERAGE: Damage for any reason to building contents or any part of the building itself, other than the installed THERMOTEK™ product, is excluded from this warranty. Among the causes of failure or damage excluded from the coverage here of are the following: 1. Damage or leaks to the caused directly or indirectly by unusual occurrences of the elements such as, but not limited to, natural forces, disasters, or acts of God including: earthquakes, cyclones, etc. 2. THERMOTEK™ GROUP shall not be liable for any incidental, consequential or other damages including, but not limited to the loss of sales, profits, inventory, or damages to the structure even if the actions provided under this warranty do not perform their specified purpose. 3. The THERMOTEK™ product fails due to alkalinity, rust, humidity and/or cracks in the surface, or any other problem related to the surface where it has been applied. This warranty is void if any of the installed THERMOTEK™ products is painted, patched or covered with any product other than THERMOTEK™ products Note: Repair leaks promptly to avoid water damage, including mold growth. 4. Damage to the THERMOTEKT products caused by misuse, abuse, falling objects, tools, foot traffic, additional equipment installation or any act(s), conduct(s) and omissions) by any person who access the roof. 5. Damage caused by clogged drains or lack of adequate drainage. 6. Damage due to ponding water (as defined by the National Roofing Contractors Association). 7. Damage or failure in any manner caused or contributed to by settlement, cracking, or other movement of the building structure. 8. Components of the THERMOTEK™ Roofing System not

manufactured by THERMOTEK™ GROUP. 9. Any acid, oil, harmful chemical, or physical reaction which comes in contact with THERMOTEK™ products, impairing their ability to resist leaks. 10. Alterations to the roof not approved in writing by THERMOTEK™ GROUP. 11. If the THERMOTEK™ product has been subject to conditions for which it is not recommended. 12. This warranty does not cover leaks or damage caused by leaks. 13. The existing roof deck has not been inspected by THERMOTEK™ GROUP and is NOT part of this Limited Warranty.

E. ENGINEERING: THERMOTEK™ GROUP does not practice Engineering or Architecture. Neither this warranty, any review of the building's construction, inspection of roof plans or roof deck by THERMOTEK™ representatives shall constitute any warranty by THERMOTEK™ GROUP. Any roof inspections are solely for the benefit of THERMOTEK™ GROUP.

F. OWNER IS RESPONSIBLE FOR ROUTINE ROOF MAINTENANCE: This "THERMOTEK™ Product Limited Warranty" is not a maintenance agreement or an insurance policy. Routine inspections and maintenance is Owner's responsibility. Inspections shall take place on a semiannual basis (twice a year according to specifications included in THERMOTEK™ Owner's Manual) and shall be documented, Periodic inspections shall include making minor repairs, cleaning off debris, filters and gutters, unclogging drains, etc. Lack of regular maintenance shall void this warranty. G. SUBMISSION OF CLAIM: In the event any leak should occur on the THERMOTEK™ Roofing System: 1. The Owner must send a: written notice to THERMOTEK™ GROUP within 30 days of the discovery of a potential claim, evidence: two samples and/or photographs from the THERMOTEK™ Roofing System (one sample must be from the suspected area and the other from another area) and an original Proof of Purchase (copies are not accepted) of THERMOTEK™ product(s) to: Pinturas Thermicas del Norte, S.A. de C.V., P.O. Box 1209 San Darlo Ave. PMB 7 - 1 Laredo, Tx. 78040-4515. (Note: By notifying THERMOTEK™ GROUP, the Owner authorizes THERMOTEK™ GROUP or its designee to investigate the case. 2. If upon investigation, THERMOTEK™ GROUP determines that the leak/damage is not excluded of Terms and Conditions, the Owner's sole and exclusive remedy will be limited to the replacement material needed repair of the leak. 3. This Limited Warranty shall be transferable subject to THERMOTEK™ GROUP inspection, written approval, and payment of the current transfer fee. 4. During the term of this Limited Warranty, THERMOTEK™ representatives shall have free access to the roof during regular business hours.

H. SOLE AND EXCLUSIVE WARRANTY: THIS WARRANTY IS EXCLUSIVE AND REPLACES ALL OTHER WARRANTIES, CONDITIONS, REPRESENTATIONS AND GUARANTEES, WHETHER EXPRESS OR IMPLIED, WHETHER BY STATUTE, AT LAW OR IN EQUITY, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THERMOTEK™ GROUP SHALL NOT BE LIABLE FOR ANY CONSEQUENTIAL, SPECIAL, INCIDENTAL OR OTHER DAMAGES INCLUDING, BUT NOT LIMITED TO LOSS OF PROFITS OR DAMAGE TO INTERIOR OR EXTERIOR OF THE BUILDING OR ITS CONTENTS, OR TO THE ROOF DECK, WHETHER FOR BREACH OF THIS WARRANTY, NEGLIGENCE, STRICT LIABILITY IN TORT, OR FOR ANY OTHER CAUSE. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES SO THE ABOVE EXCLUSIONS OR LIMITATIONS MAY NOT APPLY TO YOU. THIS WRITTEN LIMITED WARRANTY IS YOUR EXCLUSIVE WARRANTY FROM THERMOTEK™ GROUP AND REPRESENTS THE SOLE REMEDY AVAILABLE TO ANY OWNER.
